Business at hand:

Annual Budget Workshop

Fire- Has been sending out invoices for down lines, etc. Will begin sending invoices for fire response per fee schedule.

Wish list: 3X boots @ \$615 Ea, K saw @ \$3299, 2X Cold water rescue suits @ \$1598, Mobile radios @ \$3326, 2X gas monitors - \$2250, Force Entry Tool T1 @ \$2600. Gear dryer @ \$5400, 2X Turn out Gear @ \$8300, 2 Helmets @ \$1000, 3X 2 1/2" Hose = \$1500.

FD is no longer using Allied. CSI in TC may have hoses on hand.

Requested to raise secretary's salary to \$150/mo. Has taken on more responsibility. County is considering a Co wide fire authority with 1-2 employees on duty at all times. Still working on getting a tornado siren through DDA funds. Received positive support. \$50,000 going to CD. Pat still needs to add Fire Assessment to income. Truck 542 needs to be replaced = \$500K. working on getting grants.

Water/Sewer- \$90,000 Prof Services is part of grant. Talk to Rodney regarding any needs/wants.

Refuse- Increase assessment to \$90.

General- Discussed postage meter. Will have large audit this year. Brining increased to \$17,000. Increase DDA to \$13,000.

Elections needs to be doubled, we have 2 elections.

All postage goes to Township Board, not individual depts.

Discussed maintenance wages.

Discussed roof, doors, windows loan. Can use savings for roof downpayment.

New mower for cemetery- \$10,000.

Planning Commission-Request raise for Chair & Secty to \$150 and members to \$100. 8 meetings per year – 6 regular & 2 special.

Move Zoning postage to Twp Board.

Parks and Rec – include new play equip for smaller kids.

Note – Kelly had to leave early.

Deb made a motion to approve \$154.34 for 2 Go Day posters with support by Pat. Roll Call: Kelly-Absent, Pat-Yes, Kathy-Yes, Deb-Yes, Shaun-Yes. 4 Yes, 1 Absent. Motion carries.
